

#### **Calvin's Representative Church Structure**

•Purpose of the church was to nurture God's people

- •Wanted to break distinction between clergy and lay people
- •Intended church to have more lay people involved than clergy
- •Created structure with four groups-ministers of word and sacrament,

doctors, elders, and deacons - ordered ministry



#### **Ordered Ministry**

Today we have three groups of ordered ministry:

1)Ruling Elders- ministry of discernment and governance

2) Deacons- ministry of compassion and service

3) Ministers of Word and Sacrament/Teaching elders-

Ordination is perpetual

**Ordination/Installation Question** 

Will you be a faithful deacon, teaching charity, urging concern, and directing the people's help to the friendless and those in need? In your ministry will you try to show the love and justice of Jesus Christ?

### **Deacon Defined G-2.0201**

"The ministry of deacon as set forth in Scripture is one of compassion, witness, and service, sharing in the redeeming love of Jesus Christ for the poor, the hungry, the sick, the lost, the friendless, the oppressed, those burdened by unjust policies or structures, or anyone in distress. Persons of spiritual character, honest repute, exemplary lives, brotherly and sisterly love, sincere compassion, and sound judgment should be chosen for this ministry."

#### **Under Authority of Session G-2.0202**

Deacons may be individually commissioned or organized as a board of deacons. In either case, their ministry is under the supervision and authority of the session. **Ordination/Installation Question** 

Will you be a faithful ruling elder, watching over the people, providing for their worship, nurture, and service? Will you share in government and discipline, serving in governing bodies of the church, and in your ministry will you try to show the love and justice of Jesus Christ?

### Session G-3.02

- Composed of current Ruling Elders and moderator
  The session has responsibility for governing the congregation and guiding its witness to the sovereign activity of God in the world, so that the congregation is and becomes a community of faith, hope, love, and witness.
- •Size of session

### Trustee Duties (G-4.01-.02)

- The Session becomes the trustees in a unicameral board, and in a bicameral board, the corporation (church) determines another method for electing trustees.
- Must elect officers of corporation president, vicepresident, secretary, treasurer
- Fiduciary duties of 1) due care; 2) prudent investing;
  3) loyalty; and 4) obedience

#### **Ordination/Installation Question**

Will you be a faithful minister, proclaiming the good news in Word and Sacrament, teaching faith and caring for people? Will you be active in government and discipline, serving in the councils of the church; and in your ministry will you try to show the love and justice of Jesus Christ?

### **Ministers of Word and Sacrament**

• Membership in and accountability to presbytery

 Categories- installed or temporary; validated, member at large, honorably retired

### **Pastoral Authority**

- Selection of Scripture and hymns
- Content of sermon and prayers
- Voting at session and presbytery meetings
- Moderating session
- Proposing the session agenda, in consultation with the Clerk of Session
- Head of Staff
- Weddings
- Commissioned Ruling Elders

### Congregational Authority and Responsibilities

- elect Ruling Elders and Deacons
- elect at-large members to the Nominating Committee, which are the majority
- call (PNC) and dissolve installed pastors
- set Terms of Call for installed pastors
- buy and sell property
- request Presbytery dissolve the congregation

#### Councils

- Responsibilities in common- reviews
- Elected officers of each body- moderator and clerk
- Meeting format


#### Synod

#### Synod of the Northeast


19 presbyteries 1130 congregations

#### **General Assembly**

meets every other year; ~800 commissioners equal # of Ministers and Ruling Elders from 170 presbyteries based on size



### **Session Duties**

#### Including but not limited to:

- Worship (with pastor)
- Education
- Receiving members
  - Profession of faith
  - Certificate of transfer
  - Reaffirmation of faith
- Mission
- Annual Budget
- Providing for care of property
  - held in trust for PCUSA)
  - can't sell, encumber or lease (for 5+ years) without presbytery permission
- Staff hiring and dismissal, not supervision
- Church administration
  - Includes having manual of operation
