

About the Presbytery of Hudson River Media Release Opt-Out Form for Minors

The Presbytery of Hudson River (HRP) uses photographs, photographic images, names, and audio and video recordings to promote and to celebrate our presbytery's ministries.

For example, such media are used on display boards, in Power Point presentations, in print and electronic publications, HRP's Facebook site, HRP's Twitter account, the HRP website and HRP-related blogs.

IF YOU AS A PARENT OR GUARDIAN HAVE NO OBJECTION TO THE PRESBYTERY'S USE OF THE CHILD'S IMAGE, NAME OR RECORDING, YOU DO NOT NEED TO SIGN OR RETURN THIS OPT-OUT FORM.

However, some persons may choose not to have images, names or recordings of their children used and we respect their wishes. Therefore, we are providing this OPT OUT form for individuals who prefer NOT to have photographs, images, names or recordings of their children used by the presbytery.

Please return the form to the Presbytery of Hudson River, 655 Scarborough Rd., Scarborough, NY 10510. This form will be kept on file in the Presbytery of Hudson River's office.

Unless a fully executed *Media Opt Out Release* form is on file, your child's image and/or likeness may at any time be captured by still photography, videography, or other photographic or electronic means. The presbytery reserves the right to use any such image, photograph, video, or the like for any presbytery-related purpose, including but not limited to promoting, publicizing and/or advertising on behalf of the presbytery in print publications, on the Internet, or in other media such as signage and/or presentations.

MEDIA OPT-OUT RELEASE FOR MINORS

Option One: Neither my child's image nor my child's name with such image may be used.
