Note: Presbytery approved (as of 1 July 2015) recommended minimums for honoraria to pulpit supplies: \$150 for a single service; \$175 for 2 services (same day), plus mileage reimbursed at current IRS rate and \$100 for moderating a meeting, plus mileage reimbursed at current IRS rate. As churches feel it appropriate higher rates can be paid. Current IRS mileage (54.5 cents as of 1/1/18). Additional fees for other services are negotiable.
